The team also shared regular notices and represented at several virtual events.













Financial Secretary's Report

Firstly, permit me to salute one of our sisters in the '84 Set (who wishes to remain anonymous) for her dedication to giving towards the School Building Fund. The first payment into the bank in 2020 was her monthly donation, clearly referenced as Building Fund. She is the only member of our Association (at the time of writing this) who has set up a standing order explicitly referenced for the Building Fund. I implore us all to consider doing the same, no amount is too small, and every little helps.

We continue to increase in numbers, and as such, our income from dues also increased. The sum of approximately £4,800 was recorded as dues for 2020; some sisters played catch up and paid dues for previous years. Because of the coronavirus pandemic, ExCo decided against the planned increase in dues, so they remained at £30 only.

Our 2020 AGM took place at The Methodist Church Askew Road. EXCO members, and the usual sisters who always support the Alumni when invited to bring and share, provided all the food and drinks for the occasion. Therefore, the venue cost of £270 was the total cost for the 2020 AGM.

Thank you for your generosity. I look forward to us all getting together again when the lockdown is over.

During the first lockdown, we set up a Welfare Fund funded by donations. The response was tremendous, and in a matter of weeks, we raised over £700 and were able to provide assistance to some of our sisters. We made another call out for donations in December to top up the Welfare Fund. COVID 19 has changed everything; the challenges are numerous, varied and experienced differently by all. Please continue to give to the Welfare Fund so that we can continue to support one another.

Virtual events have now become the order of the day. Our first virtual event, Praise Jamboree, was where our E-magazine was launched generated a sum of £330 in donations from sisters who placed adverts in the magazine. Our Founders day 'Mindful Reflections' was a huge success. It cost us approximately £200, half of which was paid for by ExCo members.

I thank all ExCo members in 2020 for their generosity.

On the Nigerian front, we gave the sum of 5,160,000.00 Naira to the school building fund in 2020. Our balance in the Association's Nigerian bank account as of the end of December 2020 was just over 2.2 million Naira. All monies raised for the building will remain in our bank accounts in Nigeria and the UK until required to build the school block in Nigeria.

A special thank you to Sylvia Amifor for all your patience and dedication. You indeed "served in love".

Finally, I would like to remind all subscribed members that we all have an obligation to pay attention to the financial status of the Association. Please ask questions if you need clarification about any financial matter.
